#### **Session Background**



As global efforts to reform international tax and financial governance accelerate, Africa's leadership and voice have never been more critical. The 2025 G20 Presidency of South Africa presents a pivotal opportunity to elevate African priorities on the global stage championing reforms that unlock domestic resource mobilisation (DRM), curb illicit financial flows (IFFs), and support the creation of equitable global tax and debt frameworks. These reforms are essential to closing financing gaps and advancing the Sustainable Development Goals (SDGs).

This roundtable takes place at a particularly meaningful moment marking ten years since the landmark Mbeki Report on IFFs from Africa. It offers a timely platform to reflect on the continent's progress in addressing IFFs and to chart a forward-looking agenda for stronger, more equitable global tax cooperation.

A major constraint facing many African countries is the high cost of debt servicing, which diverts critical public resources away from development investments and undermines efforts to strengthen DRM. With rising interest rates and limited access to concessional financing, African governments are increasingly burdened by unsustainable debt levels. This fiscal pressure not only limits their ability to invest in tax administration and compliance systems but also weakens their negotiating power in global tax forums.

Addressing debt sustainability is therefore inseparable from the broader agenda of tax justice and financial reform.

Convened in collaboration with South Africa's National Treasury, the Tax Justice Network, the Africa-Europe Working Group on IFFs, and other strategic partners, the session will bring together African and European leaders for a frank and forward-looking exchange. Participants will explore how to align Africa's development needs with global tax reform, foster high-impact partnerships, and build a lasting legacy through South Africa's G20 Presidency and upcoming international milestones, including the Fourth International Conference on Financing for Development (FfD4) and the AU-EU Summit.

The dialogue will also examine how Europe and global institutions can support Africa's ambitions through mechanisms such as the OECD Inclusive Framework, innovative climate financing frameworks and the emerging UN Convention on International Tax Cooperation, ensuring that Africa is not only at the table but shaping the rules of the game.
